

Transaction management legacy view

Attach a receipt

Your organization may allow you to attach a receipt to a transaction. You can attach a PNG, JPG, or PDF file copy of your receipt (e.g., scanned on a copy machine into PDF format) to a transaction. The system converts all file types to a PDF after upload. You and your Program Administrator can view the attachments on the transaction list and on transaction reports.

Your organization can choose a system setting to lock transactions after a certain number of days after your cycle date so that attachments can no longer be added to the transaction. Know what your organization has set for the limit.

To attach a receipt from the transaction list, click the **Paperclip** icon in the Attachment column for the transaction you want to attach a receipt to.

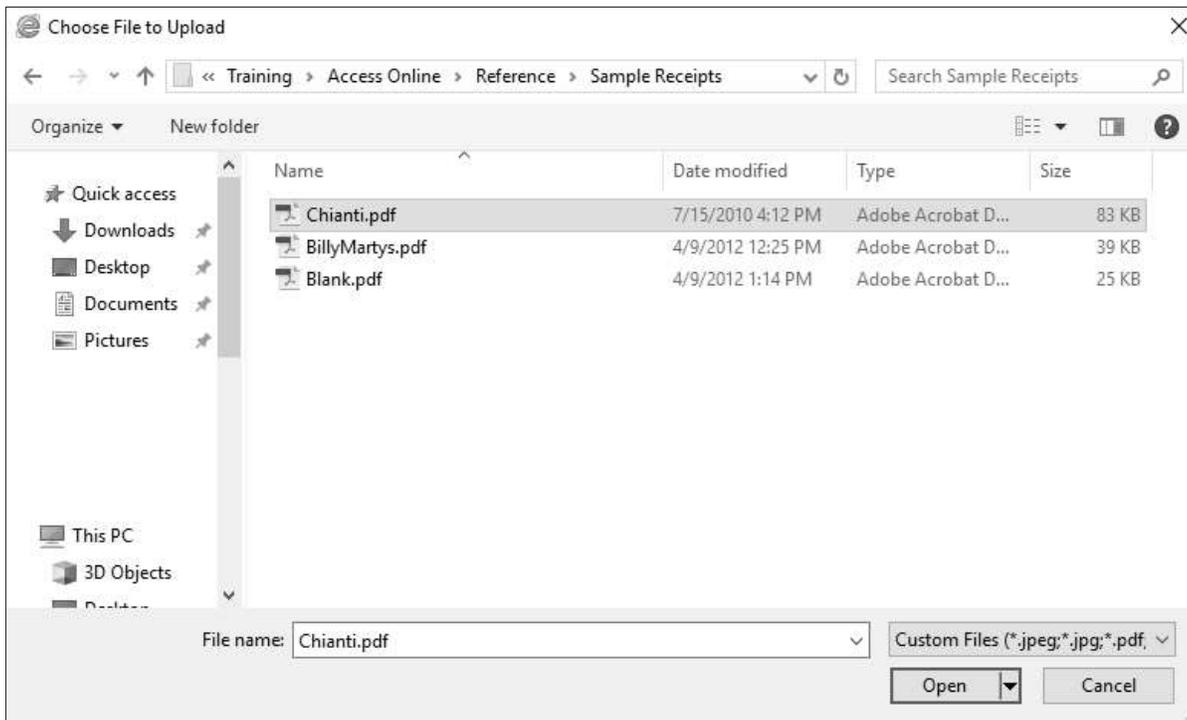
