

## Twenty-Five Competencies of Student Teaching Data-Fall 2024 (Overall)

### Data Collection

The student teaching evaluation data were collected using the new instrument in Fall 2024. The University Supervisors and the Cooperating Teachers evaluated all the candidates who completed the student teaching via TK-20. All 17 teacher candidates were evaluated, so the response rate was 100%.

### Data Analysis and the Results

Descriptive statistics were conducted for each of the 25 competencies of the student teaching evaluation data with a total of 17 student teachers. The results show that on average the teacher candidates were rated proficient or above proficient on all 25 competencies except Competencies 1.8, 1.9, 2.6 and 2.7. The mean of each item was provided in the table as follows.

All competencies are scored on a four-point scale, ranging from “not proficient” to “highly proficient.”
